The tested model of Nissan X-Trail was introduced in Australia and New Zealand in 2014. This ANCAP safety rating applies to all variants built from February 2017, except 2.0 litre diesel variants which are unrated.

Dual frontal, side chest and side head airbags (curtains) are standard. An autonomous emergency braking (AEB) system which operates at city and interurban speeds is standard on models built from February 2017. Advanced seat belt reminders are fitted to the front and 2nd row seats. Third row seats, where fitted, do not have seat belt reminders or side curtains. Occupant Protection.

Frontal Offset Test

Each body region is scored out of 4 points

Head / neck:	4.00 points
Chest:	3.88 points
Upper legs:	4.00 points
Lower legs:	2.80 points

The passenger compartment held its shape well in the frontal offset test. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash. After the crash all doors could be opened with normal effort.

Side Impact Test

Each body region is scored out of 4 points

Head:	4.00 points
Chest:	4.00 points

Pelvis:	4.00 points

Good protection was provided for the driver in the side impact test. The side airbags performed well.

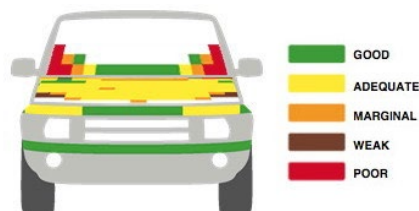
Pedestrian Protection.

Pedestrian Test

Scored out of 36 points

Adult & child head impacts: 15.44 points
Upper leg impacts: 5.84 points
Lower leg impacts: 6.00 points

This vehicle scored 27.28 out of 36 points (Acceptable). The X-Trail scored maximum points for the protection its bumper offered to pedestrians' legs, with good results recorded at all test locations. The front edge of the bonnet offered good or adequate protection. The bonnet surface provided protection that was adequate in almost all areas tested with some poor results only on the stiff windscreen pillars. (Tested by Euro NCAP v7.0)
